

From the Resource page of BPW Foundation (http://www.bpwfoundation.org/index.php/resources/) you can find numerous research options. When I was attending UNC-Asheville, working on my BS in Computer Science, I had several opportunities to write term papers. More than a few times, I turned to the research at BPW Foundation for support and ideas.

The most convenient resource is the Rawalt Online Resource Center (http://www.bpwfoundation.org/index.php/resources/rawalt_online_resource_center/) where you can access an E-Card Catalog system, as well as many reports, publications, and statistics covering BPW history, working women issues, women veterans, Generation X and Y, and other areas of interest. You can also find links to the Department of Veterans Affairs, Mobility Agenda, the US Census Bureau, and other agencies that provide statistics and information.

I remember a speech I had to write for a Humanities class; I chose women's suffrage as my topic. I used some of the historical records available from the Rawalt Online Resource Center, a clipping from the Disney movie "Mary Poppins," and my personal experiences at our

Policy & Action Conferences to develop a multimedia presentation that wowed my professor and (I hope) educated the young 18 to 22 year olds in the class (and let's just say I was about 15 years older than everyone in class). And, yes, I got the only A in a class of 20.

To continue to provide timely information and research, it is important that the BPW Foundation continues to receive our support, as it benefits us as working women and as supporters of working women and women veterans. And do not forget that you can also access the Grass roots Tools (found by clicking on the Engage link in the middle of the home page; it is then the last item in the list under What's New on the resulting page) which include the Advocacy Center, the Media Toolkit, the Equal Pay Day Toolkit, National Business Women's Week®, the graphic standards manual, suggested programming focus, and the Young Careerists Manual. We are still the grass roots of this organization, and we must not forget that.
